- 1. In these terms and conditions, the following terms shall have the following meanings:
 - a. "Promoter" = Toyota (G.B.) PLC (trading as Lexus), registered in England and Wales with company number 00916634 and its registered office address at Great Burgh, Burgh Heath, Epsom, Surrey KT18 5UX.
